49th Regeiment is reported as having been organized in August 1861. Three companys are stated to have served in the battle of Manassas, July 21, 1861, under Col. Willima Smith, prior to the organization of the Regiment. These companys formed the nucleus of the 49th Regiment. The regiment was reorganized May 1. 1862. after which the company letters were changed.

Company A, Caption Jerome B. Norwille's Company, formerly called Company F, enlisted July 1, 1861 for one year, mustered July 2, 1861, reorganized April 30, 1862. Europe Grand

Company B - Quantico Guards, Dumfries, Prince William County, formerly called Company G (2), enlised July 1, 1861 for the war, mustered July 16, 1861 and remained onduty in Dumfries until March 8, 1862, when it left and joined the regiment March 28, 1862.
