The FLINT HILL RIFLES (or, RIFLEMEN)

This Company enlisted on June 16, 1861, and elected Officers, at Flint Hill, Rappahannock County, for twelve months. The Rifles were designated Company "A" when the Regiment was formally organized during August 1861.

When the Regiment was reorganized on April 30, 1862, this became Company "E"

A great majority of the Company re-enlisted on April 30, some had re-enlisted during February 1862.

Note: This appears to be a small Company in numbers, but Flint Hill was, and still is, a tiny village in a county where two other Companies of the 49th were also raised.
